RULES AND PROCEDURE FOR ADMISSION

B.Ed. & M.Ed. Course

• Admission in B.Ed. Course in this College will be through guidelines of federation of Self-financed Colleges of Education affiliated to Panjab University, Chandigarh of Punjab. Candidates with at least 50% marks either in the Bachelor's Degree or in the Master's Degree or any other qualification declared equivalent thereto, are eligible for admission to the B.Ed. Course. Centralized admissions of B.Ed. & M.Ed. will take place as per notification of Punjab Government.

GENERAL INSTRUCTIONS FOR MIGRATION CERTIFICATE

Candidates graduated from university other than Panjab University will have to submit the Migration Certificate in original along with Original Detailed Marks Card of last exam passed within 20 days from the date of enrolment. Failing which they will have to pay penalty to Panjab University, Chandigarh as per norms of Panjab University.

MODE OF PAYMENT OF COLLEGE DUES (FEE)

Fee structure will be according to rules and regulations passed by competent authorities from time to time. The dates of payment of dues will be notified by the principal from time to time according to the following schedule:

- ➤ All the dues shall be paid at the College office on the Specific days which will be duly notified.
- Fee and Fines once paid are not refundable.

NOTE

- 1. Fee once paid shall not be refunded.
- 2. The Candidate who fail to deposit his/her fee thus misses his/her chance for

- 3. If any student does not attend the College within a week of the opening day, as announced by the College his/her admission will stand cancelled.
- 4. Students from other Universities will have to submit their migration certificate within 20 days of admission.
- 5. Students admitted under SC/ST category will have to submit their original SC/ST certificate at the time of admission or else their admission will stand cancelled.
- 6. Supplementary admission will be made as per the decision of the Centralized Admission Committee.
- 7. All dues must be cleared before final examinations.

LEAVE RULES

- 1. Leave must be sanctioned personally.
- 2. Application for leave must be signed by the parents or the guardian of the applicant. In case of illness, the application should be accompanied by a medical certificate.

RULES GOVERNING THE REFUND OF SECURITIES

- 1. The security will remain intact at the time of sending university admission forms and the issue of roll number.
- 2. Student leaving the College without completing their course can claim refund of security. Security will be refunded after the declaration of the results.

SCHOLARSHIP AND STIPENDS

- 1. All types of State, Centre and University Scholarships are tenable in the College.
- 2. Fee concessions are awarded to the deserving & needy students from the College funds.
- 3. All the students belonging to Schedule Caste/ Scheduled Tribe/ Other Backward Classes will get application form for Government of India/State Government Scholarships from the department concerned and submit them that are duly

complete within one week from the data of admission

HOUSE EXAMINATION, ATTENDANCE

- 1. House Tests are held before commencement of final examinations in each Semester. They are compulsory for the students as Internal Assessment will be made on the basis of performance of house tests, class test and assignments.
- 2. Exemption from any House Examination will not be given except under very exceptional circumstances.
- 3. Strict disciplinary action will be taken against students who absent themselves from the House Examination.
- 4. Students will have to secure at least 40% marks in each examination or else, they will not be allowed to appear in the final exams.
- 5. No mercy test will be conducted in the College. Hence the internal assessment of the students who fail to appear in the examination will not be sent.
- 6. At least 75% attendance is essential to appear in the annual examination.

INSTRUCIONS FOR STUDENTS

- 1. Wearing of the College uniform is compulsory during College hours.
- 2. The College is pledged to strict vegetarianism. Taking of meat, eggs, fish or any non Vegetarian preparation thereof is strictly prohibited in the College campus.
- 3. A student who wishes to withdraw from the College can do so by sending an application addressed to the Principal duly signed by the guardian.
- 4. Visitors are not allowed to see the students during College hours.

5. Strict disciplinary action will be taken against the student who is found using mobile phone for other than educational purpose in the College campus.

RULES AND REGULATIONS TO BE FOLLOWED BY THE STUDENTS

- 1. At the time of admission, each student is issued a library cum Identity card. Always keep this card in person.
- 2. The College will start at 9 A.M. All students should be punctual. No excuse will be entertained for the late entry in the college.
- 3. Students will not be allowed to miss the classes while in the campus. Strict disciplinary actions shall be taken against the defaulters.
- 4. Leave must be get sanctioned from College authorities in prior.
- 5. Medical leave will be granted by the Principal. The leave application should be supported by a valid medical certificate, and recommended by the tutor.
- 6. Students are advised to see the notice board daily. No excuse will be entertained if a student fails to read any important notice. Students are not allowed to remove any notice from the notice board, which has been put up by the College. Such students if Identified will be fined or liable to disciplinary action.
- 7. Students are advised to actively participate in all activities of the Colleges, so their Teachers can help them in identifying their talents. Always keep discipline and decorum.

LIBRARY

A well equipped Library with a wide variety of books and journals on educational and other topics has been provided for the benefit of students.

Library rules:

1. Two books are issued to a student for a period of 15 days only

- 2. The books will be re-issued if they are not in demand by other students.
- 3. A fine of Rs. 2 per day per volume is charged for the book returned after the due date.
- 4. Books will be re-issued for the specified period.
- 5. Reference books, text books, rare books & periodicals shall not to be issued except for consultation in the Library premises.
- 6. The students are required to possess their Identity Card while inside the Library.
- 7. Books issued from the Library should be kept very carefully and in no case be Underlined and disfigured. If the book is already damaged in any form, it should be got checked by the issuing clerk or by the librarian, otherwise the responsibility will be of the student Himself/Herself.
- 8. The loss of books should be reported to the Librarian before the due date, in the absence of which, fine will be charged till the information given. The borrower will be required to replace it. He /She will have to pay double the price along with her next College dues if the book could not be replaced.
- 9. The students are expected to observe proper silence in the library and not to disturb others in any way. Students should check whether all pages are intact or not before getting the books issued. If pages are found missing at the time of returning, then they will be fined. They should inform the librarian regarding the missing pages at the time of getting books issued and get the signature of the librarian along with the notification of missing pages.



HOUSE SYSTEM

The purpose of having 'houses' is to provide opportunities to the students for self-expression, inculcate leadership qualities to help students to shoulder responsibilities and help them to understand the concept of co-operation and team spirit. The students are divided into eight houses:

Each house functions under the charge of two lecturers and remains on duty for One week. The main duties of each house are:

- ➤ To organize at least one moral education lecture and one inter house function.
- ➤ To check cleanliness of the campus and to maintain discipline in the campus.
- > To check late comers and wrong parking of vehicles.
- ➤ To hold morning assembly.

College Uniform: For the purpose of development of virtues like discipline and simplicity among trainees, it is obligatory on the part of B.Ed. & M.Ed. & D.El.Ed. Students to wear College uniform regularly on all working days.

Academic & other Distinctions: The College has a brilliant record of University Exam results. The students of the College have been participating in various types of co-curricular positions in the university Examinations, Youth Festivals and various types of competitions.

Co-curricular Activities: Co-curricular activities form an integral part of this training course. To train the students in Youth leadership and to develop social awareness, there

Research Cell: This lab is designed to provide students with hand-on experience with an actual, ongoing research programme. All necessary reference material, dissertations and theses of M.Ed. and Ph.D Students, Synopsis of M.Ed. Dissertation of different Colleges, books and Journal of Educational Research is available in this cell.



Psychology Cell & Guidance and Counseling Cell: Experimental equipments and material in Educational Psychology etc are the contexts of this laboratory. It is a place where we pride over selves preparing students for position as university professor.

Maths and Science Laboratory: A laboratory is a facility that provides controlled conditions in which scientific research, experiments and measurements may be performed.

Centre for Educational Technology and Computer Laboratory: During the past years the College has acquired visual number of modern gadgets, equipments, audio-T.V. V.C.R, etc. This lab has computers, projectors, overhead projectors academic technology and support to aid the College community in achieving the goals of providing and receiving the best education possible while using the tools of technology.
